



ACCIDENT WAIVER AND RELEASE OF LIABILITY AGREEMENT

We are aware that these volunteer activities could be hazardous and that we could be injured or killed. We are participating in these activities with knowledge of the danger involved, and agree to assume any and all risks of bodily injury, death or property damage, whether those risks are known or unknown.

During our volunteer event **inherent hazards and risks** that we are aware of include, but are not limited to:

- Risk of injury or death from the volunteer activities and equipment utilized;
- Falling, drowning, or fishing line entanglement causing injury or death;
- All “**acts of nature**” such as inclement weather conditions, thunder and lightning, severe wind, temperature changes, water conditions, trail erosion, landslides, rock slides, flash floods, currents, and waves;
- Our own negligence and/or negligence of others around us;
- Risk of heat related issues from exhaustion, heat stroke, sunburn, & dehydration;
- Attacks, injuries, and death by encounters with insects, animals, sea life, or people;
- Risk of injury from cleaning and hazardous materials, manmade objects, and traffic;
- Our own sense of balance, physical coordination, and ability to follow instructions;

- The sudden occurrence of unknown or unanticipated risks within our surroundings.

We certify that we are physically fit and have sufficiently prepared ourselves for the volunteer activities involved during this event. We certify that there are no health related reasons or problems, which preclude us from participating in these activities.

We hereby agree, acknowledge, and understand that we release and hold harmless **808 Cleanups** with respect to any and all injury, disability, illness, death, loss, or damage to person and property, whether caused by negligence or otherwise.
